PROTECTING COMPANY CONFIDENTIAL INFORMATION

We expect that SIA "DIŽOZOLS PLUS" suppliers who have received or have access to SIA "DIŽOZOLS PLUS" proprietary information will safeguard it with the utmost care and prudence and take all necessary precautions to avoid inadvertent disclosure.

DATA PROTECTION

We expect that the suppliers of SIA "DIŽOZOLS PLUS" comply with all applicable laws relating to the protection of personal data.

PREVENTION OF CORRUPTION

SIA "DIŽOZOLS PLUS" upholds the principle of fairness in every business transaction. Any form of extortion, bribery, and/or corruption, including the offering or acceptance of bribes, material benefits, assets, or any other illegitimate advantage to employees, business partners, state and local government institutions, or any other individuals, is strictly prohibited.

FAIR COMPETITION. CONFLICTS OF INTEREST.

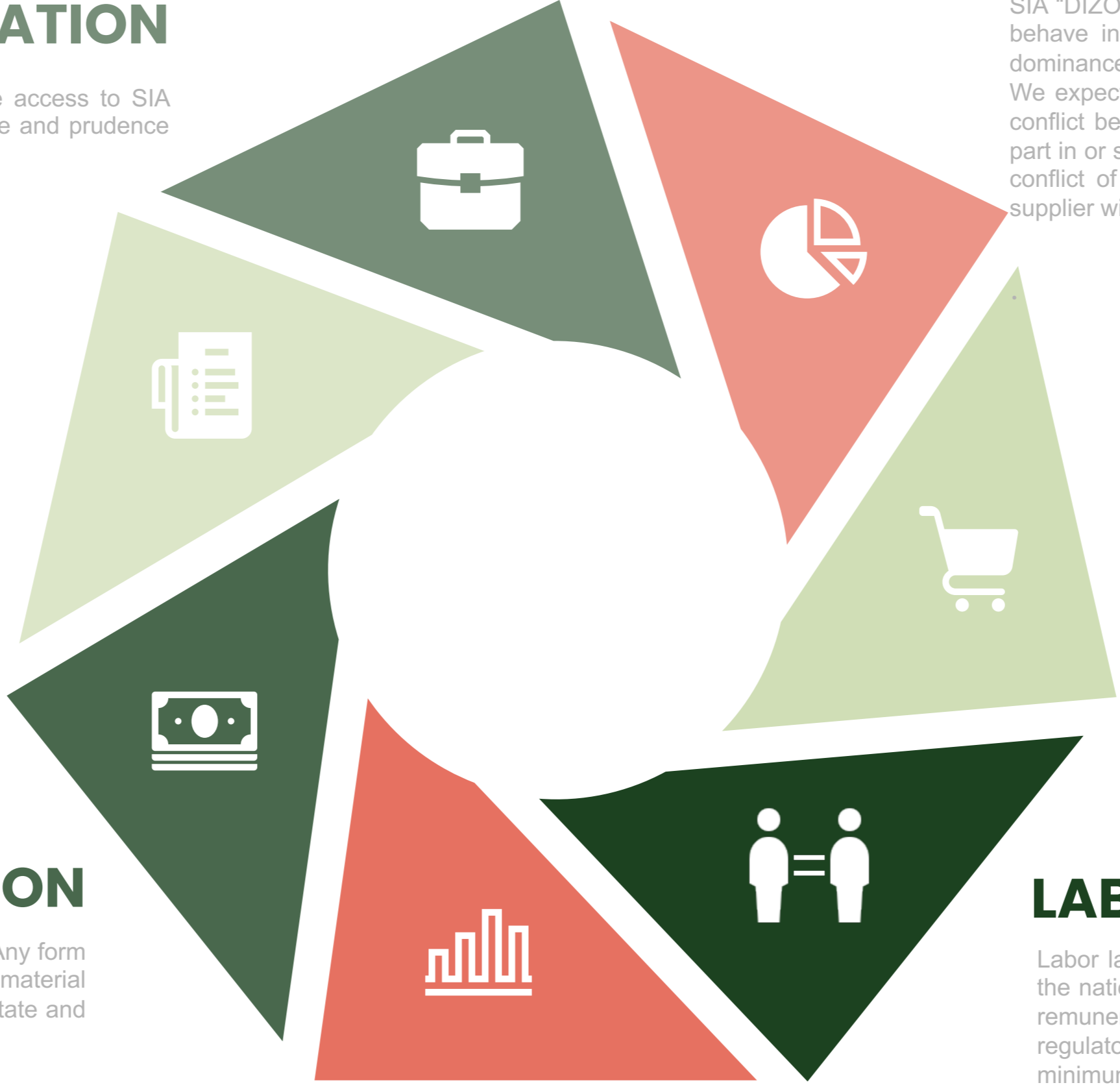

SANCTIONS

LABOR LAWS AND HUMAN RIGHTS

The Supplier ensures that its employees receive appropriate and timely remuneration for the work performed, which is not less than the minimum prescribed by the regulatory acts. Under no circumstances is forced labor used, and children younger than the minimum age set by the state in regulatory acts are employed.
